The Borough of New Eagle Council met on Tuesday, August 10, 2021, at the New Eagle Borough Municipal Building, 157 Main Street, New Eagle PA 15067.

The meeting was called to order by President J. Fine, the Pledge of Allegiance was recited.

Roll call was taken by the Borough Secretary, Kimberly Koontz, there being a quorum present the meeting was called to order.

Minutes from the July 13, 2021, meeting was presented to Council for approval. Motion was made by T. Chaney and seconded by S. Bobnar. Motion was carried by unanimous call of the roll by the Secretary.

Bills in the amount of \$43,418.65 (Bill list A \$29,139.19, Bill list B \$14,279.47) were presented to Council for approval. Motion was made by D. Walters and seconded by T. Chaney. Motion was carried by unanimous call of the roll by the Secretary.

Public Works Supervisor J. Miller gave the monthly report for the department. The following work details were completed in July. Grass cutting continued throughout the Borough. 285 feet of new asphalt curb was placed, and tar sealed. Tar sealing continues major cracks and around catch basins on 7<sup>th</sup> Avenue, Sycamore Street and Wood Street. Areas on Marion and Birch that were washed out were patched and brought up to level with existing roadway with asphalt and sealed. The 2016 Ford F550 was taken into Volker's to have the inspection done. Upon the inspection the check engine light was on, it showed that the Turbo seal was leaking. A motion was made by D. Walters and seconded by T. Chaney authorizing Volker's to complete diagnostics on the 2016 F550 and provide us with a price and results not to exceed \$800.00 and obtain warranty information. Motion was carried by unanimous call of the roll by the Secretary.

A Motion was made by T. Chaney and seconded by D. Walters to renew the Premiere Baseball League lease for Maple Avenue Ballfield from August 1, 2021, to July 31, 2022. Motion was carried by unanimous call of roll by the Secretary.

Unfinished Business:

A motion was made by T. Chaney and seconded by D. Walters to authorize Brandon Firestone from PennDot to prepare the specs and place bid for the 3<sup>rd</sup> Avenue and Vine Street paving. J. Fine voted yes, S. Bobnar voted no. Motion was carried 3 yeas and 1 no.

A motion was made by D. Walters and seconded by J. Fine to have the 7<sup>th</sup> Avenue Pond surveyed not to exceed \$1000.00. Motion was carried by unanimous call of the roll by the Secretary.

Motion to approve the repair of the 2015 F550 truck was tabled until warranty information can be obtained.


New Business:
