

**BOROUGH OF NEW EAGLE
COUNCIL MEETING
TUESDAY, OCTOBER 13, 2020**

New Eagle Borough Council met on Tuesday, October 13, 2020 in the Council Chambers, Municipal Building 157 Main Street, New Eagle, Pennsylvania 15067.

The meeting was called to order by Council President J. Fine, the Pledge of Allegiance was recited.

Roll call was taken by Kimberly Koontz, Borough Secretary, there being a quorum present the meeting was called to order.

Borough Secretary Kimberly Koontz announced that Trick or Treat for New Eagle will be on October 31st from 6 to 8 pm.

Minutes from the September 8, 2020 was presented to Council for approval. Motion to approve the minutes was made by B. Williams and seconded by T. Chaney. Motion was carried by unanimous call of the roll by the Secretary.

Motion to approve bills in the amount of \$38,693.97 (bill list A \$31,326.85, bill list B \$7,367.12) was made by B. Williams and seconded by T. Chaney. Motion was carried by unanimous call of the roll by the Secretary.

Secretary K. Koontz gave the monthly Public Works report submitted by Foreman J. Miller. Two catch basins at Sycamore and 2nd Avenue were complete rebuilds. Grass cutting continues in the Borough properties. Public works worked on the initial phase of cleaning the sediment pond at 7th Avenue and Hawthorne. Some of the material was dumped with permission on private property owned by John Sala. Maintenance continues with the Public Works vehicle fleet. The salt shed is full and ready for the snow season to begin.

T. Chaney reported that she had received layouts from our Engineer for the Maple Avenue park and the Morton Street basketball court. She has registered to attend virtually a DCNR grant program and workshop for more information on obtaining grants for the parks.

B. Williams reported that the Borough will receive it's 2021 Liquid Fuel Allocation in the amount of \$70,367.11.

The Ambulance committee has not met in a few months, there was nothing to report. T. Chaney inquired about receiving a monthly report from Tri Community. Police Chief K. Harris said to his knowledge the other communities do not receive any reports.

Police Chief K. Harris reported there has been vandalism to the Maple Avenue ballpark dug outs. Officers are doing increased patrols at the park.

Solicitor T. Berggren reported that contract negotiations with the Teamsters for the Public Works will begin on October 29th.


New Business: T. Chaney made the motion to install cameras at the Maple Avenue park due to the recent vandalism in the dugouts. The cost is not to exceed \$300.00. B. Williams seconded the motion. Motion was carried by unanimous call of the roll by the Secretary.

T. Chaney made the motion for the Pittsburg Premiere Baseball Team to fund raise by allowing sponsorship signs to be hung on the fence at the ball field. The Borough will receive fifty percent of the proceeds which will be escrowed for future park renovations. The motion was seconded by B. Williams. Motion was carried by unanimous call of the roll by the Secretary.

T. Chaney made the motion to grant permission to Cuzzy Coating's LLC to paint the buildings at the Maple Avenue ball field with no cost to the Borough. Motion was seconded by B. Williams. Motion was carried by unanimous call of the roll by the Secretary.

No further business was discussed, motion to adjourn at 7:15 pm was made by B. Williams and seconded by T. Chaney. Motion was carried by unanimous call of the roll by the Secretary.
