The Borough of New Eagle Council met in executive session from 6:45 to 7:00 pm to discuss litigation issues.

The Borough of New Eagle Council met on Tuesday, September 14, 2021, at the New Eagle Borough Municipal Building, 157 Main Street, New Eagle PA 15067.

The meeting was called to order by President J. Fine, the Pledge of Allegiance was recited.

Roll call was taken by Borough Secretary K. Koontz, there being a quorum present the meeting was called to order.

Visitors: Darlene Bright, 145 Second Ave inquired why the Veteran banners are not hung where they had been in the past years.

William Tatar, 328 7th Ave was displeased with S. Bobnar on numerous subjects he felt were unacceptable.

Larry Taylor, 600 Monroe Street addressed Council regarding the Tubby Hall Park.

Minutes from the August 10, 2021, meeting was presented to Council for approval. Motion was made by B. Williams and seconded by T. Chaney. Motion was carried by unanimous call of the roll by the Secretary.

Bills in the amount of \$53,366.90 (Bill list A \$33,466.99, Bill list B \$19,899.91) were presented to Council for approval. Motion was made by S. Bobnar and seconded by B. Williams. Motion was carried by unanimous call of the roll by the Secretary.

Public Works Foreman J. Miller reported on the department for the month of August. Grass cutting continued throughout the Borough on Borough owned properties. Catch basin at 2nd and Clifton was repaired. Catch basin at Clifton and Fair has been identified as needing repair. A deep catch basin at 1st Avenue and Marion is being replaced due to a water runoff issue at 1st and Marion. A drainage project has been started on Vine Street.

T. Chaney reported on Borough Property. She is working on funding through the DCNR and the American Rescue Plan Act for various projects that would be available to the Borough.

Secretary gave report on the Code Enforcement for the month of August.

S. Bobnar reported on the Ambulance. They continue with challenges due to COVID. They answered seventy-six calls for the Borough since January.

Unfinished Business: Motion was made by S. Bobnar and seconded by D. Walters to authorize Monongahela Public Works to pave a 100-foot section of road at Marion Street and Birch Avenue where

the roads intersect using 2" of blacktop for a cost not to exceed \$2000.00 Motion was carried by unanimous call of the roll by the Secretary.

Motion was made by T. Chaney and seconded by B. Williams to proceed with repairs to the 2015 Ford F550 to be done by Allegheny Ford at a cost not to exceed \$15,000.00. Motion was carried by unanimous call of the roll by the Secretary.

Motion was made by D. Walters and seconded by B. Williams to award the contract in the amount of \$43,858.00 to Morgan Excavating subject to review by the Borough Solicitor and Secretary.

Other Business:


Motion was made by D. Walters and seconded by B. Williams to rescind the motion for Volker's to complete diagnostics and repairs on the 2016 F550. Motion was carried by unanimous call of the roll by Secretary.

Motion was made by T. Chaney and B. Williams for Davies Ford to complete diagnostics and repair the 2016 F550 truck in the amount \$1213.39, the Goodwill program with Ford will cover \$667.36 and the Boroughs responsibility will be \$546.03. Motion was carried by unanimous call of the roll by the Secretary.

S Bobnar made a motion to resign her seat from Council, T. Chaney seconded the motion. Motion was carried with unanimous call of the roll by the Secretary.

No further business was discussed, motion to adjourn at 8:11 pm was made by B. Williams and seconded by T. Chaney.
